l,	, apply for membership in the United States Naval Sea
Cadet Co	orps. I understand my responsibilities are as follows:
1.	To attend at least 80% of all drills and activities to maintain membership in this Unit. If I am required to miss a drill, or other activity, I understand the Unit requires that I contact the Leading Petty Officer (LPO) or the Executive Officer (XO). This will be done at least twenty four hours in advance of the activity. Three consecutive unexcused absences will result in my dismissal.
2.	I am responsible for my appearance, and upkeep of my appearance and uniforms, and I also realize the importance of maintaining a proper appearance in or out of uniform. I am also responsible to bring all required uniforms to every drill. In addition I will abide by all current U.S. Navy uniform and grooming regulations and standards. Failure to do so will result in my dismissal from the Corps.
3.	Education is a major part of a Cadet's life. I understand I must maintain a minimum 2.5 grade point average to remain in the Corps I must bring my report card each semester for verification. Furthermore, I understand that academic requirements will be placed on me for (Naval Sea Cadet /Navy League Cadet) advancements and that I must advance, or attempt to advance, whenever eligible. I also understand I must attend Boot Camp (Recruit Training) during my first summer or winter break in the Sea Cadet or Navy League Cadet program, and perform at least one annual two week training, of my choice, each year thereafter. Failure to adhere to the above is cause for dismissal.
4.	I will renew my registration at least thirty (30) days in advance of the expiration date.
